OLD Business:

<u>Attorney Report:</u> Carrie Ritsert advised that each council member, mayor and city clerk need to complete a City of Beechwood Village Financial Disclosure form and send it to the City Clerk for the city's records. Carrie Ritsert, City Attorney gave her opinion after reviewing the Weyland Property Settle Agreement and Binding Elements Referenced Section D: That Weyland or his assigns or successors shall provide written notice to the city in the event that Weyland and or his assigns applies to any entity or

agency to amend any or all of these plans. This notice shall be given not less than 7 days in advance of any meeting at which the requested approval could be granted.

Section H: Weyland agrees that neither he or his partners or assigns shall in the future support any application for rezoning of any property within or immediately adjacent to the city.

The corner lot shall not be a buildable lot according to the Binding Elements. This lot was assigned as a detention basin. Various discussions and opinions were given. Mayor advised that he has been in conversation with the owner.

House Bill 12 7: KLC was apposing this bill. This bill is in regards to public utilities. Carrie advised she would have to read it in detail to give an opinion and how it would affect BWV.
