Attorney Report: Mayor advised that the discussion regarding the bright light on the rear of the house at the 100 block of Bramton Road that shines into the Resident's house on the corner of Bramton Road and Cordova Road. This light is constantly on day and night. Code Enforcement officer researched the BWV ordinances and there is further discussion regarding any additional changes in our ordinances that may need to be made. Mayor will discuss further with the City Attorney and report back at the March 2023 meeting.

<u>Old Business:</u> Curb design: Mayor emailed the engineer requesting that he bring his study and proposal at our March 2023 meeting to report his proposal regarding the new curb design.

<u>Waste Management:</u> Mayor discussed the various problems noted from residents that WM is picking up recycling and putting it in the garbage pick up trucks. City Clerk will begin the process for Request for Proposals with the various Garbage Waste Management vendors in the Jefferson County area in order to compile a comparison pricing for the various services.

<u>City of Lyndon Police Chief:</u> Mayor reported that he received a phone call from the Mayor of the City of Lyndon advising that Chief Grady Throneberry was fired due to management disagreements and Deputy Police Chief Rob Schroder called BWV (our) mayor and introduced himself. He advised that all services would remain the same as before for the police patrol. Mayor mentioned to Chief Schroder the double-parking problem in the 200 Block of Bramton Road and he said he would look into this for us.
